AGREED MINUTES

of the Latvian - Slovenian Joint Committee meeting on International Road Transport held in Riga, 21st – 22nd September, 2016

The following agenda was agreed by the delegations:

- 1. Exchange of information regarding the development of trade and road transport between the Republic of Latvia and Slovenia.
- 2. Social issues in road transport, including road transport initiatives of the European Commission, proposals for amending the posting directive, minimum wage issue in the EU and control practices.
- 3. Exchange of information on implementation practice of Regulation (EU) No 165/2014 regarding tachograph checks and liability of workshops performing such controls.
- 4. Transport of goods by road, including exchange of views concerning further development of the ECMT quota system.
- 5. International passenger transport, including passenger rights in bus transport and cabotage.
- 6. Miscellaneous, including:
 - a. Checking validity of a Community licence and copies of Community licence over a public website;
 - b. Exchange of information on practices of suspending and withdrawal of the Community licences due to reported infringement and exchanging of such type of information via ERRU:
 - c. Planned implementation of the Commission Regulation (EU) 2016/403 of 18 March 2016 supplementing Regulation (EC) No 1071/2009 of the European Parliament and of the Council with regard to the classification of serious infringements of the Union rules, which may lead to the loss of good repute by the road transport operator, and amending Annex III to Directive 2006/22/EC of the European Parliament and of the Council;
 - d. Exchange of information on Uber type of taxi services and existing legal frameworks for such type of services.

1. Exchange of information regarding the development of trade and road transport between the Republic of Latvia and Slovenia

The delegations informed each other about trade relations between both countries and about the organization of the road transport sectors in each of them. The Latvian delegation presented information on passenger and goods transport by road in Latvia, as well as information on international trade between Latvia and Slovenia.

The Latvian side noted that during the year 2015 in comparison with the previous year the export volume in EUR to Slovenia slightly increased by 0,9% but the import volume from Slovenia decreased by 20.1%. Conversely in tons export volume decreased by 7.6% and import volume decreased by 4,1%.

The total trade turnover in EUR between both countries during 2015 decreased by 15,9% and constituted 41,1 million EUR. At the same time the trade turnover in tons decreased by 6,1%.

In EUR the import of goods from Slovenia to Latvia exceeds export from Latvia to Slovenia 3,2 times but in tons export from Latvia to Slovenia exceeds import of goods from Slovenia 1.3 times. It means that more valuable goods are imported from Slovenia to Latvia.

The Latvian side informed that the main types of goods imported from Slovenia are products of the chemical or allied industries (49,4%), machinery, mechanical appliances and electrical equipment (23,4%), transport vehicles (10%). The main types of goods exported to Slovenia are articles of stone, plaster, cement, glass and ceramics (30,1%), machinery, mechanical appliances and electrical equipment (15,8%), products of the chemical or allied industries (15.5%).

The Slovenian delegation informed about their statistical data and noted that it reflects the same tendencies.

The Latvian delegation informed about the structure of the heavy goods vehicle fleet and noted that in 2015, in comparison with the previous year, the fleet involved in international carriage of goods increased by 2.8% and reached 14709 units. The number of Latvian companies involved in international goods transport operations decreased by 0.7% and at the end of the year there were 3920 such companies.

The Slovenian delegation informed about their structure of the heavy goods vehicle fleet and noted that 6500 Slovenian companies are operating in international market. The number of vehicles involved in international carriage of goods is approximately 17000 units.

Both sides expressed hope that the trade turnover and the number of international goods transport operations between Latvia and Slovenia will increase in the nearest future.

2. Social issues in road transport, including road transport initiatives of the European Commission, proposals for amending the posting directive, minimum wage issue in the EU and control practices

The delegations exchanged views regarding public consultation on the review on Regulation 1071/2009 and Regulation 1072/2009 launched by the European Commission.

The delegations exchanged their positions on initiatives of the European Commission concerning cabotage. It was noted that both countries consider that there is no need to amend the existing provisions regulation haulage cabotage in the EU area and that in a long term period cabotage operations should be liberalized.

The concerns were expressed about the extending of minimum wage law in Germany and France to foreign international road transport companies and administrative barriers related to that as well as about interpreting the Directive on posting of workers in a similar way by some other western countries. It was also noted that the ban introduced by Belgium and France to spend regular weekly 45-hour rest period in a vehicle and very high fines applied in case of non-compliance shall be regarded as social protectionism measures.

Both delegations shared the viewpoint that the outcome of the infringement procedure in case of Germany and the pilot case on minimum wage requirements in France is going to be of great importance for forming social policies in the EU countries. It was agreed to join efforts for stopping social protectionism practices in the EU area.

3. Exchange of information on implementation practice of Regulation (EU) No 165/2014 regarding tachograph checks and liability of workshops performing such controls

Taking into consideration that Regulation (EU) No 165/2014 provides the necessity to ensure that fitters and workshops are competent and reliable and for that purpose a set of clear national procedures shall be established and published the delegations exchanged information on developing national legislation on activities of tachograph workshops and problems related to that as well as on control practices and sanctions in case of tachograph manipulations.

4. Transport of goods by road, including exchange of views concerning further development of the ECMT quota system

The delegations noted that the ECMT quota system is experiencing serious problems because of existing numerous restrictions and protectionism policies of some countries. It was stressed that the further functioning of the quota is of high importance and both countries are going to join their efforts to continue functioning of the system.

It was noted that Latvia and Slovenia have completed the necessary official procedures to declare being the Quality Charter compliant and the hope was expressed that during the upcoming Road Transport Group meeting the respective applications will be approved.

5. International passenger transport, including passenger rights in bus transport and cabotage.

The delegations noted that there are four regular passenger lines operated in transit through Slovenia.

With regard to the implementation of Regulation 181/2011 concerning the rights of passengers in bus and coach transport and amending Regulation (EC) No 2006/2004 (further – Regulation 181/2011) the Latvian delegation informed that responsible for the enforcement of this Regulation is the Road Transport Administration and it is also dealing with personal claims of bus passengers as an appeal body. Latvia has opted to implement exceptions for domestic regular services and bus lines to third countries by March 2017 and plans to extend these exceptions for another four year period by March 2021.

The Slovenian delegation informed that the competent authority for passenger rights in Slovenia is the Ministry of Infrastructure and personal claims of bus passengers shall be submitted to it directly and that it is also planning to extend exceptions under Regulation 181/2011 related to domestic regular services and bus lines to third countries for another four year period.

The positions were exchanged on the draft Protocol to the Agreement on the international occasional carriage of passengers by coach and bus (Interbus Agreement) regarding the international regular and special regular carriage of passengers by coach and bus launched recently by the European Commission.

Both delegations expressed concern that the existing provisions for performing passenger service cabotage under the framework of Regulation 1073/2009 can be widely interpreted and it has led to a number problem situations therefore there is a need to address the European Commission for drafting more detailed regulation in this area.

6. Miscellaneous:

a. Checking validity of a Community licence and copies of Community licence over a public website;

The Latvian delegation presented the system of checking validity of a Community licence and copies of Community licence over a public website (http://www.atd.lv/lv/licences).

The Slovenian delegation indicated that there is a similar system of checking validity of a Community licence and copies of Community licence over a public website (http://nerdcp.gov.si/javni).

b. Exchange of information on practices of suspending and withdrawal of the Community licences due to reported infringement and exchanging of such type of information via ERRU

Both delegations exchanged information on the existing practices of suspending and withdrawal of the Community licences due to reported infringement and exchanging of such type of information via ERRU. The Latvian delegation stressed that there are cases when the information on infringements received via ERRU is incorrect or insufficient therefore companies under discussion are asked to submit written explanations prior examining compliance with the good repute criteria.

c. Planned implementation of Commission Regulation (EU) 2016/403 of 18 March 2016 supplementing Regulation (EC) No 1071/2009 of the European Parliament and of the Council with regard to the classification of serious infringements of the Union rules, which may lead to the loss of good repute by the road transport operator, and amending Annex III to Directive 2006/22/EC of the European Parliament and of the Council

Both delegations exchanged information on identified problems regarding implementation of Commission Regulation (EU) 2016/403. The Latvian delegation stressed that one of the difficulties is that in case of repeated infringements by one and the same company the seriousness which may lead to the loss of good repute is evaluated on the basis of a number of drivers employed by a particular company but such type of information is not fixed in any of public data bases. It was also noted that the deadline for implementation is very short – 01.01.2017 and that a range of amendments should be made in a national legislation to comply with the Regulation.

The Slovenian delegation pointed out that till the end of 2016 all the necessary amendments to comply with Commission Regulation (EU) 2016/403 are going to be introduced.

d. Exchange of information on Uber type of taxi services and existing legal frameworks for such type of services

It was noted that in a number of cases Uber type of taxi services has caused distortion of competition and a special legal regulation is needed. Both countries are in a process of developing such legislation or amending already existing and experience was exchanged thereof.

The meeting was held in a friendly and constructive atmosphere. Both delegations emphasized the usefulness of the meeting.
